Sale of Adval Tech's Bodenweid plant to Stoppani sealed

Niederwangen/Neuenegg, December 20, 2010, 7.15 a.m. – As announced on November 26, 2010, Adval Tech's Bodenweid plant, which is operated by Styner+Bienz FormTech Ltd, is to be acquired by Stoppani AG, Neuenegg, with effect from the beginning of January 2011. Adval Tech Holding Ltd and Stoppani AG signed the relevant contract last Friday evening. The plant in Bern-Bümpliz, which is engaged in the production of sheet metal housings and non-tool-dependent sheet metal processing in small lots, no longer forms part of the Adval Tech Group's strategic sphere of activities. The group has established itself in recent years as an industrial partner operating on a global scale, supplying volume components in metals and plastics in large unit numbers for selected markets in the automotive, medical technology and consumer goods industries. For Stoppani AG, which operates in the machinery, high-tech and medical industries, the Bodenweid plant ideally complements its existing activities. Stoppani will retain all 63 employees. Both parties have agreed not to disclose the purchase price.
